**Private instruction is 25/30 minutes** - Instruction time is 25 minutes and will extend to make 30, but if a parent needs to chat please advise the instructor at the start of your child's lesson. The lesson will end earlier or start later to offer a buffer to answer any parental questions without impacting the next participant's lesson time.

**Lesson Policies:**

1. Please ensure that your child(ren) arrive at least 5 minutes early for lesson start, and that they have visited the washroom before the lesson begins.
2. Missed classes cannot be made up. Lessons will run during inclement weather, cool temperatures & rain, but not during unsafe weather.
3. Once you have registered & paid there will be no refunds issued.
4. If the swimmer will not attend due to medical circumstance, upon receipt of a medical note, a prorated refund will be given minus a \$25.00 admin fee.
5. The wading pool is closed to parents and children staying on deck at the pool as spectators during lessons.
6. Parents and other children are asked to sit well away from the pool edge/deck so adequate space is available for teaching groups & instructors.
7. Please do not interrupt or call out to the instructor or your child during an active lesson as this is distracting for the instructor and other students.
8. Semi-Private groups must be arranged by parent in advance and should be no more than 1 lesson level apart.
9. For safety reasons, children age 7 and under must be within arm's reach of a responsible person age 14+ when on the pool deck and in the building.
